

## D) Information on Personal Data processing

We would like to inform you that personal data you provide to us in connection with your application for access to medical records or copies or extracts from medical records (or an application for information from medical documentation), in particular, non-exhaustively, by completing the relevant forms (or by submitting the application in a free form) (hereinafter referred to as "**Personal Data**"), will be processed by Controller exclusively for the purpose of processing your application and fulfilling the related legal obligations (e.g. the obligation to retain Personal Data for a certain period, etc.). We are obliged to handle your application in accordance with the AHS or other legal regulations. Personal Data processing is necessary for fulfilling our legal obligation. In connection with your application, you are not obliged to provide us with your Personal Data, but if you do not, it will not be possible to process your application. Your Personal Data may be transferred without your consent only to those recipients who have access to it on the basis of legal regulations. We will retain your Personal Data for the same period as we retain the Patient's personal data contained in their medical records, because Personal Data will be part of them and at the same time, they will be registered for the duration of our legitimate interest in the registration of applications.

You may request access to Personal Data from us (i.e., in particular, to request information on the categories of Personal Data processed, the purpose, time, and nature of the processing and the recipients of the Personal Data); you are also entitled to request a copy of the processed Personal Data under the conditions contained in legal regulations; you are entitled to ask, under conditions contained in the relevant legal regulations, that Personal Data be corrected, supplemented, or deleted, or that its processing be restricted; you are entitled to object to Personal Data processing and lodge a complaint with the supervisory authority, which is the Office for Personal Data Protection, Pplk.
